We are delighted to share some news regarding your Select Checking account. Starting May 20, 2024, your Select Checking account will include the following NEW and ENHANCED benefits:¹

NEW Fuel Savings²

Register for the Fuel Rewards® program and save 5¢/gal on every fill-up at participating Shell stations with Extended Gold Status.

NEW Dark Web Monitoring

Monitor your personal information on the dark web and receive alerts when your personal information is exposed (registration/activation required).

NEW Roadside Assistance³

24-hour roadside assistance including vehicle towing, fuel/oil/fluid/water delivery, and battery/lock-out/tire assistance up to \$100 per occurrence. Maximum of two occurrences per twelve-month period.

NEW Telehealth4

Access to 24/7 video or phone visits with U.S.-based board-certified, licensed and credentialed doctors ready to help with urgent care or mental health for you and your family, all at no additional cost.

NEW Credit Score Simulator⁵

Use the Score Simulator to see how increasing card limits, or paying off a loan, will impact your VantageScore.

NEW Rideshare Protection³

Up to \$100,000 of AD&D coverage and \$10,000 of accident medical expense benefit if injured while traveling in a vehicle operated by a Transportation Network Company, as defined in the insurance certificate.
