## Washington Federal Announces 18% Increase in Cash Dividend

SEATTLE, WASHINGTON – The Board of Directors of Washington Federal, Inc. (NASDAQ-WAFD), today announced a quarterly cash dividend of 13 cents per share. The payout represents an increase of 2 cents, or 18%, over the prior quarterly dividend of 11 cents per share. This included a 3.67 cent increase over the prior quarter dividend of 11 cents as a one-time payment in anticipation of a change in the schedule of quarterly payments and represents an additional one month's dividend income to compensate for the new schedule. The current dividend will be payable on February 16, 2015 to common stockholders of record on February 2, 2015. In the future, the board will consider declaring cash dividends in the months of January, April, July and October, for payment in February, May, August, and November. This will be Washington Federal's 128<sup>th</sup> consecutive quarterly cash dividend.
